49. The preceding paragraphs are incorporated by reference.

50. As described with further particularity in the Brief accompanying these Preliminary Objections, Ms. Geer is not the trustee of the Dille Family Trust and had no standing to seek the relief described in her Petition.

51. Under to Rule 3.9(b)(4) of the Pennsylvania Orphans' Court Rules, the Petition is legally insufficient.

52. Accordingly, the Court should sustain the Beneficiaries' Preliminary Objections and dismiss Ms. Geer's Petition or, in the alternative, stay this case pending adjudication of the California Case.

WHEREFORE, the Beneficiaries respectfully request that this Court enter an Order, substantially in the form attached hereto, dismissing Ms. Geer's Petition, or in the alternative, staying this action, pending adjudication of the California Case.
